## A BILL FOR AN ACT

To amend Public Law No. 22-157, as amended by Public Laws Nos 22-179 and 22-205, by amending section 6 thereof, to extend the lapse date of fund previously appropriated therein, to fund public projects and social programs for the people of Yap, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 22-157, as amended by
Public Law No. 22-179, is hereby further amended to read as
follows:

4 "Section 6. Allotment and management of funds and lapse 5 date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in 6 accordance with applicable laws, including, but not 7 8 limited to, the Financial Management Act of 1979. The 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are used 11 solely for the purpose specified in this act, and that 12 no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated 13 14 under section 2 of this act shall be the Governor of Yap 15 State or his designee. The allottee of funds appropriated under sections 3 and 4 of this act shall be 16 the President of the Federated States of Micronesia or 17 his designee; EXCEPT THAT, the allottee of funds 18

2	Governor of Kosrae State or his designee; the allottee

1 act shall be the Meninkeder Lapalap of Madolenihmw; the 2 allottee of funds appropriated under sections 4(3)(k)and 4(3)(m) of this act shall be the Vice President of 3 the Federated States of Micronesia or his designee; the 4 allottee of funds appropriated under section 4(3)(1) of 5 6 this act shall be the Secretary of the Department of 7 Education or his designee;. The allottee of the funds appropriated under subsections 5(1) and 5(6) of this act 8 shall be the Governor of Chuuk State or his designee; 9 10 the allottee of the funds appropriated under subsection 5(2) of this act shall be the Mortlocks Island 11 12 Development Authority (MIDA); the allottee of the funds appropriated under subsection 5(3) of this act shall be 13 14 the Mayor of Weno Municipal Government or his designee; the allottee of the funds appropriated under subsection 15 5(4) of this act shall be the Southern Namoneas 16 17 Development Authority; the allottee of the funds appropriated under subsection 5(5) of this act shall be 18 the Faichuk Development Authority. The authority of the 19 20 allottee to obligate funds appropriated by this act 21 shall lapse on September 30, [2024] 2026." 22 23
