

A BILL FOR AN ACT

To appropriate the sum of \$1,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2017, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,400,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal year
4 ending September 30, 2017, for the purpose of funding public
5 projects and social programs for the people of Yap, Kosrae,
6 Pohnpei and Chuuk States. The fund shall be apportioned as
7 follows:

8 Section 2. Of the sum of \$1,400,000 appropriated by this
9 act, \$200,000 is apportioned for Yap State for public projects
10 and social programs.

11 (1) State of Yap\$ 200,000

12 Section 3. Of the sum of \$1,400,000 appropriated by
13 this act, \$200,000 is apportioned for Kosrae State for
14 public projects and social programs.

15 (1) State of Kosrae 200,000

16 Section 4. Of the sum of \$1,400,000 appropriated by this
17 act, \$400,000 is apportioned for Pohnpei State for public
18 projects and social programs.

19 State of Pohnpei 400,000

5 Section 5. Of the sum of \$1,400,000 appropriated by this
 6 act, \$600,000 is apportioned for Chuuk State for public
 7 projects and social programs.

11	(3) Election District No. 2	100,000

15 Section 6. Allotment and management of funds and lapse
 16 date. All funds appropriated by this act shall be allotted,
 17 managed, administered and accounted for in accordance with
 18 applicable laws, including, but not limited to, the Financial
 19 Management Act of 1979. The allottee shall be responsible for
 20 ensuring that these funds, or so much thereof as may be
 21 necessary, are used solely for the purpose specified in this
 22 act, and that no obligations are incurred in excess of the sum
 23 appropriated. The allottee of the funds appropriated under
 24 section 2 of this act shall be the Governor of Yap State or his
 25 designee. The allottee of funds appropriated under sections 3
 26 and 4 of this act shall be the President of the Federated

1 States of Micronesia or his designee. The allottee of funds
2 appropriated under subsections 5(1), 5(3) and 5(6) of this act
3 shall be the Governor of Chuuk State or his designee. The
4 allottee of funds appropriated under subsection 5(2) of this
5 act shall be the Mortlock Islands Development Authority. The
6 allottee of funds appropriated under subsection 5(4) of this
7 act shall be the Faichuk Development Authority. The allottee
8 of funds appropriated under subsection 5(5) of this act shall
9 be the Southern Namoneas Development Authority. The authority
10 of the allottee to obligate funds appropriated by this act
11 shall lapse on September 30, 2018.

12 Section 7. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its
14 becoming law without such approval.
