

A BILL FOR AN ACT

To appropriate the sum of \$1,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2019, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,400,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2019, for the purpose of funding public projects and
5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk
6 states. The funds appropriated under this section shall be
7 apportioned as follows:

8 Section 2. Of the \$1,400,000 appropriated under this act,
9 \$200,000 shall be apportioned for public projects and social
10 programs for the people of Yap State.

11 state of Yap..... \$ 200,000

12 Section 3. Of the \$1,400,000 appropriated under this act,
13 \$200,000 shall be apportioned for public projects and social
14 programs for the people of Kosrae State.

15 state of Kosrae.....\$ 200,000

16 Section 4. Of the \$1,400,000 appropriated under this act,
17 \$400,000 shall be apportioned for public projects and social
18 programs for the people of Pohnpei State.

6 Section 5. Of the \$1,400,000 appropriated under this act,
 7 \$600,000 shall be apportioned for public projects and social
 8 programs for the people of Chuuk State.

16 Section 6. Allotment and management of funds and lapse date.
 17 All funds appropriated by this act shall be allotted, managed,
 18 administered and accounted for in accordance with applicable laws,
 19 including, but not limited to, the Financial Management Act of
 20 1979. The allottee shall be responsible for ensuring that these
 21 funds, or so much thereof as may be necessary, are used solely for
 22 the purpose specified in this act, and that no obligations are
 23 incurred in excess of the sum appropriated. The allottee of the
 24 funds appropriated under section 2 of this act shall be the
 25 Governor of Yap State or his designee. The allottee of funds

1 appropriated under sections 3 and 4 of this act shall be the
2 President of the Federated States of Micronesia or his designee.
3 The allottee of the funds appropriated under subsections 5(1),
4 5(3) and 5(6) of this act shall be the Governor of Chuuk State or
5 his designee; the allottee of the funds appropriated under
6 subsection 5(2) of this act shall be the Mortlocks Island
7 Development Authority (MIDA); the allottee of the funds
8 appropriated under subsection 5(4) of this act shall be the
9 Southern Namoneas Development Authority; the allottee of the funds
10 appropriated under subsection 5(5) of this act shall be the
11 Faichuk Development Authority. The authority of the allottee to
12 obligate funds appropriated by this act shall lapse on September
13 30, 2021.”

14 Section 7. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.
