

A BILL FOR AN ACT

To appropriate the sum of \$2,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,100,000, or so much thereof as  
2 may be necessary, is hereby appropriated from the General Fund  
3 of the Federated States of Micronesia for the fiscal year ending  
4 September 30, 2020, for the purpose of funding public projects  
5 and social programs for the people of Yap, Kosrae, Pohnpei and  
6 Chuuk states. The funds appropriated under this section shall  
7 be apportioned as follows:

8 Section 2. Of the \$2,100,000 appropriated under this act,  
9 \$300,000 shall be apportioned to fund public projects and  
10 social programs for the people of Yap State.

12 Section 3. Of the \$2,100,000 appropriated under this act,  
13 \$300,000 shall be apportioned to fund public projects and  
14 social programs for the people of Kosrae State.

18 Section 4. Of the \$2,100,000 appropriated under this act,

1 \$600,000 shall be apportioned to fund public projects and  
 2 social programs for the people of Pohnpei State.

8 Section 5. Of the \$2,100,000 appropriated under this act,  
 9 \$900,000 shall be apportioned to fund public projects and  
 10 social programs for the people of Chuuk State.

18 Section 6. Allotment and management of funds and lapse  
 19 date. All funds appropriated by this act shall be allotted,  
 20 managed, administered and accounted for in accordance with  
 21 applicable laws, including, but not limited to, the Financial  
 22 Management Act of 1979. The allottee shall be responsible for  
 23 ensuring that these funds, or so much thereof as may be  
 24 necessary, are used solely for the purpose specified in this  
 25 act, and that no obligations are incurred in excess of the sum

1 appropriated. The allottee of the funds appropriated under  
2 section 2 of this act shall be the Governor of Yap or his  
3 designee. The allottee of the funds appropriated under  
4 subsection 3(1) of this act shall be the Governor of Kosrae or  
5 his designee. The allottee of the funds appropriated under  
6 subsection 3(2) of this act shall be the Mayor of Lelu Town  
7 Government or his designee. The allottee of the funds  
8 appropriated under section 4 of this act shall be the President  
9 of the Federated States of Micronesia or his designee. The  
10 allottee of the funds appropriated under subsections 5(1) and  
11 5(6) of this act shall be the Governor of Chuuk State or his  
12 designee; the allottee of the funds appropriated under  
13 subsection 5(2) of this act shall be the Mortlocks Island  
14 Development Authority (MIDA); the allottee of the funds  
15 appropriated under subsection 5(3) of this act shall be the  
16 Mayor of Weno Municipal Government or his designee; the allottee  
17 of the funds appropriated under subsection 5(4) of this act  
18 shall be the Southern Namoneas Development Authority; the  
19 allottee of the funds appropriated under subsection 5(5) of this  
20 act shall be the Faichuk Development Authority. The authority  
21 of the allottee to obligate funds appropriated by this act shall  
22 lapse on September 30, 2022.
