## A BILL FOR AN ACT

To amend section 802 of title 11 of the Code of the Federated States of Micronesia (Annotated), as amended, in order to clarify the enforceability of an emergency decree, eliminate the time restriction on the enforcement of emergency decrees, and prohibit the importation, purchase and sale of dangerous weapons during an emergency, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 802 of title 11 of the Code of the
- 2 Federated States of Micronesia (Annotated), as amended, is hereby
- 3 amended to read as follows:
- 4 "Section 802. Emergency restrictions.
- 5 (1) During the existence of a state of emergency, the 6 President may, by proclamation, prohibit:
- 7 (a) any person being on the public roads or at any 8 other public place during the hours proclaimed by the 9 President to be a period of curfew;
  - (b) the manufacture, transfer, use, possession, or transportation of any device or object designed to explode or produce uncontained combustion;
  - (c) the transportation, possession, or use of combustible, flammable, or explosive materials in a container of any kind except in connection the normal operation of motor vehicles, motor boats, normal home use, or legitimate commercial use;

| 18 | becomes effective immediately upon being signed by the     |
| 19 | President, who shall immediately give public notice of     |
| 20 | its contents by the most effective means available, with   |
| 21 | exceptions and areas designated by proclamation of the     |
| 22 | President.   |
| 23 | [(3) Prohibitions imposed by proclamation issued under     |
| 24 | this section, shall automatically terminate at noon on     |
