

A BILL FOR AN ACT

To further amend Public Law No. 20-68, as amended by Public Laws Nos. 20-78, 20-89, 20-176, 21-95 and 21-138, by amending sections 2 and 5 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 20-68, as amended  
2 by Public Laws Nos. 20-78 and 21-95, is hereby further  
3 amended to read as follows:

4 "Section 2. Of the sum of \$1,440,000 appropriated  
5 by this act, \$240,000 is apportioned for public  
6 projects and social programs in the state of  
7 Kosrae.

4 Section 2. Section 5 of Public Law No. 20-68, as amended  
5 by Public Laws Nos. 20-89, 21-95 and 21-138, is hereby  
6 further amended to read as follows:

7 "Section 5. Allotment and management of funds and lapse  
8 date. All funds appropriated by this act shall be  
9 allotted, managed, administered and accounted for in  
10 accordance with applicable laws, including, but not  
11 limited to, the Financial Management Act of 1979. The  
12 allottee shall be responsible for ensuring that these  
13 funds, or so much thereof as may be necessary, are used  
14 solely for the purpose specified in this act, and that  
15 no obligations are incurred in excess of the sum  
16 appropriated. The allottee of the funds appropriated  
17 under sections 2 and 3 of this act shall be the  
18 President of the Federated States of Micronesia or his  
19 designee; PROVIDED THAT the allottee of funds  
20 appropriated under subsections 2(a), 2(b), 2(h) and 2(i)  
21 of this act shall be the Mayor of Lelu Town Government  
22 or his designee; the allottee of funds appropriated  
23 under subsections 2(c) to 2(g) of this act shall be the  
24 ~~[Mayor of Tafunsak Municipal Government]~~ Governor of  
25 Kosrae State or his designee; the allottee of funds

1 appropriation under subsection 3(1)(i) of this act shall  
2 be the Chief Magistrate of Sokehs Municipal Government  
3 or his designee; the allottee of funds appropriated  
4 under subsection 3(2)(a) of this act shall be the  
5 President of the COM-FSM Institute or his designee; the  
6 allottee of funds appropriated under subsection 3(2)(b)  
7 of this act shall be the Pohnpei Transportation  
8 Authority; the allottee of funds appropriated under  
9 subsections 3(2)(c) to 3(2)(g) of this act shall be the  
10 Secretary of the Department of Transportation,  
11 Communications and Infrastructure or his designee; the  
12 allottee of funds appropriated under subsections 3(4)(a)  
13 shall be the President of the COM-FSM Institute or his  
14 designee; the allottee of funds appropriated under  
15 subsection 3(4)(b) of this act shall be the Mayor of  
16 Pingelap Municipal Government or his designee; the  
17 allottee of funds appropriated under subsection 3(4)(c)  
18 of this act shall be the Mayor of Mwokilloa Municipal  
19 Government or his designee. The allottee of funds  
20 appropriated under subsections 4(1) and 4(6) of this act  
21 shall be the Governor of Chuuk State or his designee.  
22 The allottee of funds appropriated under subsection 4(2)  
23 of this act shall be the Mortlock Islands Development  
24 Authority. The allottee of funds appropriated under  
25 subsection 4(3) of this act shall be the Mayor of Weno
