## A BILL FOR AN ACT

To amend section 221 of title 54 of the Code of the Federated States of Micronesia (Annotated), as amended, to increase the import duties levied on vehicles, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 221 of title 54 of the Code of the
- 2 Federated States of Micronesia (Annotated), as amended, is
- 3 hereby amended to read as follows:
- 4 "Section 221. Levy and rates.
- 5 The following import duties are hereby levied on
- 6 all products specified herein which are imported
- 7 into the FSM:
- 8 (1) cigarettes, at the rate of \$0.025 per
- 9 cigarette, provided that this rate shall increase
- 10 by \$0.005 per cigarette on January 1 of each of
- 11 the years 2007, 2009, 2011, 2013 and 2015;
- 12 (2) tobacco, other than cigarettes, at the rate
- of 50 percent ad valorem;
- 14 (3) perfumery, cosmetics, and toiletries,
- including cologne and other toilet waters,
- 16 articles of perfumery, whether in sachets or
- otherwise, and all preparations used as
- applications to the hair or skin, lipsticks,
- 19 pomades, powders, and other toilet preparations

1	not having medicinal properties, at the rate of
2	25 percent ad valorem;
3	(4) soft drinks, drink mixes, drink
4	preparations, coffee, tea, and nonalcoholic
5	beverages, at the rate of 25 percent ad valorem,
6	provided, however, that any beverage having a
7	fruit juice content of 25 percent or more by
8	volume shall be at the rate of three percent ad
9	valorem;
10	(5) beer and malt beverages, at the rate of
11	<pre>\$0.25 per 12 fluid ounces;</pre>
12	(6) distilled alcoholic beverages, at the rate
13	of 12 dollars per gallon;
14	(7) wine at the rate of 30 percent ad valorem;
15	(8) foodstuffs for human consumption, at the
16	rate of three percent ad valorem; provided,
17	however, that fresh and frozen fish and seafood,
18	shall be at the rate of 25 percent ad valorem;
19	(9) gasoline and diesel fuel, at the rate of
20	five cents per gallon;
21	(10) laundry bar soap, at the rate of 25 percent ac
22	valorem; [and]
23	(11) automobiles weighing less than 1,400 kg, at
24	the rate of 10 percent, CIF;
