
A BILL FOR AN ACT

To further amend Public Law No. 21-80, as amended by Public Laws Nos. 21-99, 21-110, 21-143, 21-181, 21-188, 21-214 and 21-242, by amending section 6 thereof, to change the allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-80, as amended by
2 Public Laws Nos. 21-99, 21-110, 21-143 and 21-181, is hereby
3 further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee; PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(a) of this act
17 shall be the President of COM-FSM; the allottee of funds
18 appropriated under subsections 2(c) and 2(d) of this act

1 shall be the President of the Federated States of
2 Micronesia or his designee. The allottee of funds
3 appropriated under sections 3 and 4 of this act shall be
4 the President of the Federated States of Micronesia or
5 his designee; PROVIDED THAT, the allottee of funds
6 appropriated under subsection 3(1) of this act shall be
7 the Governor of Kosrae State or his designee; the
8 allottee of funds appropriated under subsection 3(2) of
9 this act shall be the Mayor of Lelu Town Government or
10 his designee; the allottee of funds appropriated under
11 subsections 4(2) of this act shall be the Secretary of
12 the Department of Transportation, Communications and
13 Infrastructure, except that the allottee funds
14 appropriated under subsection 4(2)(f) shall be the
15 Pohnpei Port Authority (PPA); the allottee of funds
16 appropriated under subsections 4(3)(a), 4(3)(1) and
17 4(3)(m) of this act shall be the Pohnpei Transportation
18 Authority (PTA); the allottee of funds appropriated
19 under subsections 4(3)(b) and 4(3)(c) of this act shall
20 be the Luhkenmoanlap of Kitti; the allottee of funds
21 appropriated under subsections 4(3)(d), 4(3)(e),
22 4(3)(f), 4(3)(g) and 4(3)(o) of this act shall be the
23 Meninkeder of Madolenihmw; the allottee of funds
24 appropriated under subsections 4(3)(i) and 4(3)(j) of
25 this act shall be the Secretary of the Department of

1 Health and Social Affairs or his designee; the allottee
2 of funds appropriated under subsection 4(3)(h) of this
3 act shall be the Director of [~~COM-FSM~~] COM Land Grant
4 Program or his designee; the allottee of funds
5 appropriated under subsection 4(3)(n) of this act shall
6 be the Vice President of the Federated States of
7 Micronesia or his designee. The allottee of the funds
8 appropriated under subsections 5(1) and 5(6) of this act
9 shall be the Governor of Chuuk State or his designee;
10 the allottee of the funds appropriated under subsection
11 5(2) of this act shall be the Mortlocks Island
12 Development Authority (MIDA); the allottee of funds
13 appropriated under subsection 5(3) of this act shall be
14 the Mayor of Weno Municipal Government or his designee;
15 the allottee of the funds appropriated under subsection
16 5(4) of this act shall be the Southern Namoneas
17 Development Authority; the allottee of the funds
18 appropriated under subsection 5(5) of this act shall be
19 the Faichuk Development Authority. The authority of the
20 allottee to obligate funds appropriated by this act
21 shall lapse on September 30, 2022.”

2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
