

A BILL FOR AN ACT

To further amend Public Law No. 20-125, as amended by Public Laws Nos. 20-135, 20-146, 20-157, 20-179, 20-189, 21-06, 21-40, 21-59, 21-89, 21-96, 21-141, 21-155, 21-217, 21-230, 21-239 and 22-20, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 20-125, as amended
2 by Public Laws Nos. 20-135, 20-146, 20-157, 21-40, 21-96, 21-141,
3 21-155, 21-217, 21-230, 21-239 and 22-20, is hereby further
4 amended to read as follows:

5 "Section 4. Of the \$7,000,000 appropriated under this
6 act, \$2,000,000 shall be apportioned for public projects
7 and social programs for the people of Pohnpei State.

22 Section 2. Section 6 of Public Law No. 20-125, as amended by
 23 Public Laws Nos. 20-135, 20-157, 20-179, 21-40, 21-89, 21-141,
 24 21-155, 21-230 and 21-239, is hereby further amended to read as
 25 follows:

1 "Section 6. Allotment and management of funds and lapse
2 date. All funds appropriated by this act shall be
3 allotted, managed, administered and accounted for in
4 accordance with applicable laws, including, but not
5 limited to, the Financial Management Act of 1979. The
6 allottee shall be responsible for ensuring that these
7 funds, or so much thereof as may be necessary, are used
8 solely for the purpose specified in this act, and that
9 no obligations are incurred in excess of the sum
10 appropriated. The allottee of the funds appropriated
11 under section 2 of this act shall be the Governor of Yap
12 State or his designee. The allottee of funds
13 appropriated under sections 3 and 4 of this act shall be
14 the President of the Federated States of Micronesia or
15 his designee; PROVIDED THAT, the allottee of funds
16 appropriated under subsections 3(a) to 3(q) of this act
17 shall be the Mayor of Lelu Town Government or his
18 designee; the allottee of funds appropriated under
19 subsection 4(2)(g) of this act shall be the Mayor of
20 Nukuoro Municipal Government or his designee; the
21 allottee of funds appropriated under subsection 4(2)(j)
22 of this act shall be the President of the COM-FSM
23 College or his designee; the allottee of funds
24 appropriated under subsection 4(2)(p) of this act shall
25 be the Pohnpei Utility Corporation; the allottee of

1 funds appropriated under subsections 4(2)(a), (b), (c),
2 (d), (e), (f), (h), (i), (k), (l), (m), (n), (o), (q),
3 (r), (s) and (v) of this act shall be the Secretary of
4 the Department of Transportation, Communications and
5 Infrastructure or his designee. The allottee of the
6 funds appropriated under subsections 4(4)(j) of this act
7 shall be the Mayor of Pingelap Municipal Government or
8 his designee; the allottee of funds appropriated under
9 subsection 4(4)(k) of this act shall be the Mayor of
10 Mwokilloa Municipal Government or his designee. The
11 allottee of funds appropriated under subsections 4(1)(s)
12 and 4(4)(m) of this act shall be the Pohnpei
13 Transportation Authority. The allottee of the funds
14 appropriated under subsections 5(1) and 5(6) of this act
15 shall be the Governor of Chuuk State or his designee;
16 the allottee of the funds appropriated under subsection
17 5(2) of this act shall be the Mortlocks Island
18 Development Authority (MIDA); the allottee of the funds
19 appropriated under subsection 5(3) of this act shall be
20 the Mayor of Weno Municipal Government or his designee;
21 the allottee of the funds appropriated under subsection
22 5(4) of this act shall be the Southern Namoneas
23 Development Authority; the allottee of the funds
24 appropriated under subsection 5(5) of this act shall be
25 the Faichuk Development Authority. The authority of the

1 allottee to obligate funds appropriated by this act
2 shall lapse on September 30, 2022.”

3 Section 3. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.
