

A BILL FOR AN ACT

To further amend Public Law No. 21-80, as amended by Public Laws Nos. 21-99, 21-110, 21-143, 21-181, 21-188, 21-214, 21-242, 22-19, 22-38, 22-56 and 22-99, by amending sections 4 and 6 thereof, to change the use, allottee and lapse date of certain funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 21-80, as amended by
2 Public Laws Nos. 21-143, 21-181, 22-19 and 22-56, is hereby
3 further amended to read as follows:

4 "Section 4. Of the \$4,200,000 appropriated under this
5 act, \$1,200,000 shall be apportioned for public projects
6 and social programs for the people of Pohnpei State.

3 Section 2. Section 6 of Public Law No. 21-80, as amended by
4 Public Laws Nos. 21-99, 21-110, 21-143, 21-181 and 22-19, is
5 hereby further amended to read as follows:

6 "Section 6. Allotment and management of funds and lapse
7 date. All funds appropriated by this act shall be
8 allotted, managed, administered and accounted for in
9 accordance with applicable laws, including, but not
10 limited to, the Financial Management Act of 1979. The
11 allottee shall be responsible for ensuring that these
12 funds, or so much thereof as may be necessary, are used
13 solely for the purpose specified in this act, and that
14 no obligations are incurred in excess of the sum
15 appropriated. The allottee of the funds appropriated
16 under section 2 of this act shall be the Governor of Yap
17 State or his designee; PROVIDED THAT, the allottee of
18 funds appropriated under subsection 2(a) of this act
19 shall be the President of COM-FSM; the allottee of funds
20 appropriated under subsections 2(c) and 2(d) of this act
21 shall be the President of the Federated States of
22 Micronesia or his designee. The allottee of funds
23 appropriated under sections 3 and 4 of this act shall be
24 the President of the Federated States of Micronesia or
25 his designee; PROVIDED THAT, the allottee of funds

1 appropriated under subsection 3(1) of this act shall be
2 the Governor of Kosrae State or his designee; the
3 allottee of funds appropriated under subsection 3(2) of
4 this act shall be the Mayor of Lelu Town Government or
5 his designee; the allottee of funds appropriated under
6 subsections 4(2) of this act shall be the Secretary of
7 the Department of Transportation, Communications and
8 Infrastructure, except that the allottee funds
9 appropriated under subsection 4(2)(f) shall be the
10 Pohnpei Port Authority (PPA);the allottee of funds
11 appropriated under subsection 4(2)(r) of this act shall
12 be the Pohnpei Transportation Authority (PTA); the
13 allottee of funds appropriated under subsections
14 4(3)(a), 4(3)(l) and 4(3)(m) of this act shall be the
15 Pohnpei Transportation Authority (PTA); the allottee of
16 funds appropriated under subsections 4(3)(b) and 4(3)(c)
17 of this act shall be the Luhkenmoanlap of Kitti; the
18 allottee of funds appropriated under subsections
19 4(3)(e), 4(3)(f), 4(3)(g) and 4(3)(o) of this act shall
20 be the Meninkeder of Madolenihmw; the allottee of funds
21 appropriated under subsections 4(3)(i) and 4(3)(j) of
22 this act shall be the Secretary of the Department of
23 Health and Social Affairs or his designee; the allottee
24 of funds appropriated under subsection 4(3)(h) of this
25 act shall be the Director of COM Land Grant Program or

1 his designee; the allottee of funds appropriated under
2 subsection 4(3)(n) of this act shall be the Vice
3 President of the Federated States of Micronesia or his
4 designee. The allottee of the funds appropriated under
5 subsections 5(1) and 5(6) of this act shall be the
6 Governor of Chuuk State or his designee; the allottee of
7 the funds appropriated under subsection 5(2) of this act
8 shall be the Mortlocks Island Development Authority
9 (MIDA); the allottee of funds appropriated under
10 subsection 5(3) of this act shall be the Mayor of Weno
11 Municipal Government or his designee; the allottee of
12 the funds appropriated under subsection 5(4) of this act
13 shall be the Southern Namoneas Development Authority;
14 the allottee of the funds appropriated under subsection
15 5(5) of this act shall be the Faichuk Development
16 Authority. The authority of the allottee to obligate
17 funds appropriated by this act shall lapse on September
18 30, [~~2022~~] 2024."

19 Section 3. This act shall become law upon approval by the
20 President of the Federated States of Micronesia or upon its
21 becoming law without such approval.
