

A BILL FOR AN ACT

To further amend Public Law No. 18-117, as amended by Public Laws Nos. 18-120, 19-04, 19-08, 19-35, 19-49, 19-59, 19-76, 19-102, 20-26, 20-117, 21-27, 21-114, 21-166, 22-13, 22-71 and 22-121, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 18-117, as amended by
2 Public Laws Nos. 18-120, 19-04, 19-08 and 22-71, is hereby further
3 amended to read as follows:

4 "Section 3. Of the sum of \$2,800,000 appropriated by this
5 act, \$400,000 is apportioned for Kosrae State for public
6 projects and social programs.

8 Section 2. Section 6 of Public Law No. 18-117, as amended
9 by Public Laws Nos. 19-04, 19-59, 19-102, 20-26, 20-117, 21-27,
10 21-166, 22-13 and 22-121, is hereby further amended to read as
11 follows:

12 "Section 6. Allotment and management of funds and lapse
13 date. All funds appropriated by this act shall be
14 allotted, managed, administered and accounted for in
15 accordance with applicable laws, including, but not
16 limited to, the Financial Management Act of 1979. The
17 allottee shall be responsible for ensuring that these
18 funds, or so much thereof as may be necessary, are used
19 solely for the purpose specified in this act, and that no
20 obligations are incurred in excess of the sum
21 appropriated. The allottee of the funds appropriated
22 under section 2 of this act shall be the Governor of Yap
23 State; PROVIDED THAT, the allottee of funds appropriated
24 under subsection 2(i) shall be the President of COM-FSM.
25 The allottee of funds appropriated under sections 3 and 4

1 of this act shall be the President of the Federated
2 States of Micronesia or his designee, PROVIDED THAT, the
3 allottee of funds appropriated under sections
4 3(a)(b)(c)(d)(e)(f)(g)(h)(i)(j)(k)(l) and (m) shall be
5 the Mayor of Lelu Town Government; the allottee of funds
6 appropriated under sections 3(n), 3(o), 3(p), 3(q), 3(r),
7 3(s), 3(t), 3(u), 3(v), 3(w), 3(x), 3(y) and 3(z) of this
8 act shall be the Governor of Kosrae State or his
9 designee; the allottee of funds appropriated under
10 subsections 4(1) and 4(2)(i) of this act shall be the
11 Secretary of the Department of Transportation,
12 Communications and Infrastructure or his designee; the
13 allottee of funds appropriation under sections 4(1)(a),
14 4(1)(b), 4(1)(d), 4(3)(a) and 4(3)(f) of this act shall
15 be the Pohnpei Transportation Authority; the allottee of
16 funds appropriated under section 4(3)(h) of this act
17 shall be the Meninkeden Lapalap of Madolenimw and the
18 allottee of funds appropriated under section 4(3)(i) of
19 this act shall be the Luhkenmoanlap of Kitti. The
20 allottee of funds appropriated under subsections 5(1),
21 5(3) and 5(6) of section 5 of this act shall be the
22 Governor of Chuuk State or his designee. The allottee of
23 funds appropriated under subsection 5(2) of section 5 of
24 this act shall be the Mortlock Islands Development
25 Authority. The allottee of funds appropriated under

1 subsection 5(4) of section 5 of this act shall be the
2 Southern Namoneas Development Authority. The allottee of
3 funds appropriated under subsection 5(5) of section 5 of
4 this act shall be the Faichuk Development Authority. The
5 authority of the allottee to obligate funds appropriated
6 by this act shall lapse on September 30, 2024.”

7 Section 3. This act shall become law upon approval by the
8 President of the Federated States of Micronesia or upon its
9 becoming law without such approval.
