A BILL FOR AN ACT

To amend title 51 of the Code of the Federated States of Micronesia (Annotated) by amending section 112 and inserting a new section 116 thereof, for the purpose of establishing a minimum wage for resident workers hired by foreign contractors, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 112 of Title 51 of the Code of the
- 2 Federated States of Micronesia (Annotated) is hereby amended to
- 3 read as follows:
- 4 "Section 112. Definitions.
- For the purposes of this chapter, unless it is

 otherwise provided or the context requires a different

 construction, application, or meaning:
- 8 (1) "Available" means able to be on the island on
 9 which the employer desires workers on the date the
 10 employer states the workers are desired.
- 12 (2) "Chief" means the chief of the Division of
 12 Labor within the Department of Resources and
 13 Development.
- 14 (3) "District representative" means any district
 15 employment service officer, or any other person
 16 designated by the chief to act on his behalf in any
 17 district in which there is no district employment
 18 service officer.

1	(4) "Employer" means any individual, partnership,
2	association, or corporation hiring employees in the
3	Trust Territory and any individual who has in his
4	employ a domestic servant, but does not include any
5	branch or agency of the Trust Territory Government or
6	of the United States Government.
7	(5) "Employment service" means the Trust Territory
8	Employment Service established under section 151 of
9	this chapter.
10	(6) "Foreign contractor" means any sole
11	proprietorship, partnership, company, corporation,
12	joint venture, or other association of persons
13	engaging in business, performing services as a
14	contractor or subcontractor, that is
15	(a) majority-owned by noncitizens of the
16	Federated States of Micronesia, or
17	(b) performing services funded by a foreign
18	donor.
19	$[\frac{(6)}{(7)}]$ "Employment service officer" means the
20	official who is the head of the Trust Territory
21	Employment Service established under section 151 of
22	this chapter.
23	$[\frac{(7)}{(8)}]$ "Nonresident worker" means any person who is
24	capable of performing services or labor and who is not
25	a citizen of the Trust Territory or an immigrant alien

1	admitted to the Trust Territory for permanent
2	residence under the provisions of title 50 of this
3	code, including persons acting in a professional,
4	managerial, or executive capacity.
5	$[\frac{(8)}{(9)}]$ "Resident worker" means any person who is
6	capable of performing services or labor and who is a
7	citizen of the Trust Territory or an immigrant alien
8	admitted to the Trust Territory for permanent
9	residence under the provisions of title 50 of this
10	code, including persons acting in a professional,
11	managerial, or executive capacity."
12	Section 2. Title 51 of the Code of the Federated States of
13	Micronesia (Annotated) is hereby amended to insert a new
14	section 116 to read as follows:
15	"Section 116. Minimum wage for resident workers hired
16	by foreign contractors.
17	A foreign contractor shall pay to each resident worker
18	hired by the foreign contractor a minimum wage of not
19	less than \$2.50 per hour for work performed in the
20	Federated States of Micronesia."
