

A BILL FOR AN ACT

To amend Public Law No. 22-37, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein for the purpose of funding public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 22-37 is hereby
2 amended to read as follows:

3 "Section 4. Of the \$2,800,000 appropriated under this act,
4 \$800,000 shall be apportioned for public projects and social
5 programs for the people of Pohnpei State.

16 Section 2. Section 6 of Public Law No. 22-37 is hereby
 17 amended to read as follows:

18 "Section 6. Allotment and management of funds and lapse
 19 date. All funds appropriated by this act shall be allotted,
 20 managed, administered and accounted for in accordance with
 21 applicable laws, including, but not limited to, the Financial
 22 Management Act of 1979. The allottee shall be responsible for
 23 ensuring that these funds, or so much thereof as may be necessary,
 24 are used solely for the purpose specified in this act, and that no
 25 obligations are incurred in excess of the sum appropriated. The

1 allottee of the funds appropriated under section 2 of this act
2 shall be the Governor of Yap State or his designee. The allottee
3 of funds appropriated under sections 3 and 4 of this act shall be
4 the President of the Federated States of Micronesia or his
5 designee; PROVIDED THAT the allottee of funds appropriated under
6 section 3(1) of this act shall be the Governor of Kosrae State or
7 his designee; the allottee of funds appropriated under section
8 3(2) of this act shall be the Mayor of Lelu Town Government or his
9 designee; the allottee of funds appropriated under sections 4(1),
10 4(2) and 4(3) of this act shall be the Secretary of the Department
11 of Transportation, Communications and Infrastructure or his
12 designee, except that the allottee of funds appropriated under
13 subsection 4(2)(k) of this act shall be the President of COM-FSM
14 or his designee; the allottee of funds appropriated under
15 subsections 4(3)(d) and 4(4)(a) of this act shall be the Pohnpei
16 Transportation Authority (PTA); the allottee of funds appropriated
17 under subsection 4(3)(e) of this act shall be the Secretary of the
18 Department of Health and Social Affairs or her designee. The
19 allottee of the funds appropriated under subsections 5(1) and 5(6)
20 of this act shall be the Governor of Chuuk State or his designee;
21 the allottee of the funds appropriated under subsection 5(2) of
22 this act shall be the Mortlocks Island Development Authority
23 (MIDA), the allottee of funds appropriated under section 5(3) of
24 this act shall be the Mayor of Weno Municipality or his designee;
25 the allottee of the funds appropriated under subsection 5(4) of

1 this act shall be the Southern Namoneas Development Authority; the
2 allottee of the funds appropriated under subsection 5(5) of this
3 act shall be the Faichuk Development Authority. The authority of
4 the allottee to obligate funds appropriated by this act shall
5 lapse on September 30, 2023.”

6 Section 3. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its
8 becoming law without such approval.
