

A BILL FOR AN ACT

To amend Public Law No. 22-48, by amending section 5 thereof, to change the use of funds previously appropriated therein for the purpose of funding public projects and social programs in the state of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 22-48 is hereby
2 amended to read as follows:

3 "Section 5. Of the \$4,200,000 appropriated under this act,
4 \$1,800,000 shall be apportioned for road improvement for
5 the people of Chuuk State.
