

A BILL FOR AN ACT

To amend Public Law No. 21-228, as amended by Public Laws Nos. 21-248, 22-12, 22-22, 22-36, 22-74, 22-90, 23-18 and 23-25, by amending section 3 thereof, to change the use of funds appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 21-228, as amended by
2 Public Laws Nos. 21-248 and 23-25 is hereby further amended to
3 read as follows:

4 "Section 3. Of the \$2,800,000 appropriated under this
5 act, \$400,000 shall be apportioned for public projects
6 and social programs for the people of Kosrae State.
