
A RESOLUTION

Authorizing the President to submit the National Government Compact Budget Request, as revised pursuant to Congress's recommendations, to the United States under Article V of the Fiscal Procedures Agreement.

1 WHEREAS, the Federated States of Micronesia and the
2 United States of America have entered into a Compact of Free
3 Association, as amended; and

4 WHEREAS, title 55 of the Code of the Federated States of
5 Micronesia, at section 103(4)(d), requires the President of
6 the Federated States of Micronesia to submit to Congress a
7 Recommended National Government Compact Budget Request for the
8 ensuing fiscal year; and

9 WHEREAS, title 55 of the Code of the Federated States of
10 Micronesia, at section 103(5)(b), permits the Congress, by
11 resolution, to recommend changes to the Recommended National
12 Government Compact Budget Request in any respect consistent
13 with the Compact, as amended; now, therefore,

14 BE IT RESOLVED by the Seventeenth Congress of the
15 Federated States of Micronesia, First Regular Session, 2011,
16 that Congress recommends the following changes to the
17 Recommended National Government Compact Budget Request:

18 For the Education Sector Grant: reduce the total request
19 to \$4,437,560 and make the following changes in distribution
20 of the proposed use funds: reduce the portion of the National

1 Department of Education FY2012 operating budget funded from
2 the Education Sector Grant by \$173,805 pursuant to specific
3 line-item changes made in Standing Committee Report No. 17-09,
4 as adopted by Congress, and increase the request for the
5 portion of National Scholarship funded from the Education
6 Sector Grant by \$172,303;

7 For the Health Sector Grant: maintain the total request
8 of \$878,750; however, the request should follow the line-item
9 breakdown pursuant to Standing Committee Report No. 17-10, as
10 adopted by Congress;

11 For the Infrastructure Sector Grant: reduce the request
12 to \$930,324 to be used to fund the operations of the Project
13 Management Unit, pursuant to the line-item breakdown provided
14 in Standing Committee Report 17-11, as adopted by Congress;
15 and

16 BE IT FURTHER RESOLVED that pursuant to title 55 of the
17 Code of the Federated States of Micronesia, section 103(7),
18 the President of the Federated States of Micronesia is hereby
19 authorized to submit the National Government Compact Budget
20 Request, in conformity with the terms of this resolution, to
21 the United States under Article V of the Fiscal Procedure
22 Agreement; and

25 BE IT FURTHER RESOLVED that certified copies of this

1 resolution be transmitted to the President of the Federated
2 States of Micronesia, and to the Embassy of the United State
3 of America in Kolonia.
