PUBLIC LAW NO. 19-78

A BILL FOR AN ACT

To further amend Public Law No. 19-10, as amended by Public Laws Nos. 19-26, 19-42, 19-51, 19-56 and 19-72, by amending sections 2, 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Yap and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 19-10, as amended by
2 Public Law No. 19-42, is hereby further amended to read as follows:

3 "Section 2. Of the sum of \$2,800,000 appropriated by
4 this act, \$400,000 is apportioned for public projects and
5 social programs in the state of Yap.

18 Section 3. Section 6 of Public Law No. 19-10, as amended
 19 by Public Laws Nos. 19-26, 19-42 and 19-51, is hereby further
 20 amended to read as follows:

21 "Section 6. Allotment and management of funds and
 22 lapse date. All funds appropriated by this act shall
 23 be allotted, managed, administered and accounted for
 24 in accordance with applicable laws, including, but not
 25 limited to, the Financial Management Act of 1979. The

1 allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are
3 used solely for the purpose specified in this act, and
4 that no obligations are incurred in excess of the sum
5 appropriated. The allottee of the funds appropriated
6 under section 2 of this act shall be the Governor of
7 Yap State; PROVIDED THAT, the allottee of funds
8 appropriated under subsection 2(h) of this act shall
9 be the President of COM-FSM. The allottee of funds
10 appropriated under sections 3 and 4 of this act shall
11 be the President of the Federated States of Micronesia
12 or his designee; PROVIDED THAT, the allottee of funds
13 appropriated under subsections 3(a), (b), (c), (d),
14 (e), (f), (g), (h), 9(i), (j) and (k) of this act
15 shall be the Mayor of Lelu Town Government; the
16 allottee of funds appropriated under subsections
17 4(2)(g) and 4(2)(h) shall be the Secretary of the
18 Department of Transportation, Communications and
19 Infrastructure; the allottee of funds appropriated
20 under subsections 4(3)(a) and 4(3)(b) of this act
21 shall be the Pohnpei Transportation Authority; and the
22 allottee of funds appropriated under subsections
23 4(3)(f) and 4(3)(h) of this act shall be the Pohnpei
24 Utility Corporation. The allottee of funds
25 appropriated under subsections 5(1), 5(3) and 5(6) of

1 this act shall be the Governor of Chuuk State or his
2 designee. The allottee of funds appropriated under
3 subsection 5(2) of this act shall be the Mortlock
4 Islands Development Authority. The allottee of funds
5 appropriated under subsection 5(4) of this act shall
6 be the Southern Namoneas Development Authority. The
7 allottee of funds appropriated under subsection 5(5)
8 of this act shall be the Faichuk Development
9 Authority. The authority of the allottee to obligate
10 funds appropriated by this act shall lapse on
11 September 30, 2017."

12 Section 4. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its
14 becoming law without such approval.
