## AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59, 18-86, 19-11, 19-106, 19-110, 20-108, 21-16, 21-122 and 22-124, by amending section 6 thereof, for the purpose of extending the lapse date of certain funds previously appropriated therein, to fund public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 16-49, as amended by
- 2 Public Laws Nos. 17-10, 17-45, 17-85, 18-28, 18-86, 19-11, 19-106,
- 3 19-110, 20-108, 21-16, 21-122 and 22-124, is further hereby
- 4 amended to read as follows:
- 5 "Section 6. Allotment and management of funds and lapse 6 date. All funds appropriated by this act shall be 7 allotted, managed, administered and accounted for in 8 accordance with applicable law, including, but not 9 limited to, the Financial Management Act of 1979. 10 allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 11 12 solely for the purpose specified in this act, and that no 13 obligations are incurred in excess of the sum 14 appropriated. The allottee of funds appropriated under 15 sections 2 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; 16

1	PROVIDED THAT the allottee of funds appropriated under
2	section 4(1)(b) shall be the Pohnpei Transportation
3	Authority and the allottee of the funds appropriated
4	under section 4(1)(j) shall be the Mayor of Kolonia Town
5	Government. The allottee of funds appropriated under
6	section 3 of this act shall be the Governor of Yap State.
7	The allottee of funds appropriated under subsections
8	5(1), $5(6)$ and $5(7)$ of this act shall be the Governor of
9	Chuuk State or his designee. The allottee of funds
10	appropriated under subsection 5(2) of this act shall be
11	the Mortlock Islands Development Authority (MIDA). The
12	allottee of funds appropriated under subsection 5(3) of
13	this act shall be the Mayor of Weno Municipal Government
14	or his designee. The allottee of funds appropriated under
15	subsection 5(4) of this act shall be the Southern
16	Namoneas Development Authority. The allottee of funds
17	appropriated under subsection 5(5) of this act shall be
18	the Faichuk Development Authority. The funds
19	appropriated by this act shall lapse on September 30,
20	2026."
