

AN ACT

To further amend Public Law No. 17-59, as amended by Public Laws Nos. 17-63, 17-66, 17-70, 17-77, 17-86, 18-21, 18-29, 18-64, 18-83, 19-18, 19-113, 20-126, 21-25, 21-86, 21-130 and 22-127, by amending section 6 thereof, for the purpose of extending the lapse date of certain funds previously appropriated therein, to fund public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 17-59, as amended
2 by Public Laws Nos. 17-63, 18-21, 18-64, 18-83, 19-18, 19-113,
3 20-126, 21-25, 21-130 and 22-127, hereby further amended to
4 read as follows:

5 "Section 6. Allotment and management of funds and
6 lapse date. All funds appropriated by this act shall
7 be allotted, managed, administered and accounted for
8 in accordance with applicable laws, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee shall be responsible for ensuring that these
11 funds, or so much thereof as may be necessary, are
12 used solely for the purpose specified in this act, and
13 that no obligations are incurred in excess of the sum
14 appropriated. The allottee of the funds appropriated
15 under section 2 of this act shall be the Governor of
16 Yap State; EXCEPT THAT, the allottee of funds

1 appropriated under subsection 2(a) shall be the
2 President of the Federated States of Micronesia or his
3 designee and the allottee of funds appropriated under
4 subsection 2(c) shall be the President of COM-FSM or
5 his designee. The allottee of funds appropriated
6 under sections 3 and 4 of this act shall be the
7 President of the Federated States of Micronesia or his
8 designee; EXCEPT THAT, the allottee of funds
9 appropriated under subsection 3(a) of this act shall
10 be the Mayor of Lelu Municipal Government or his
11 designee. The allottee of funds appropriated under
12 subsection 4(3)(1) shall be the Land Grant Project
13 Coordinator. The allottee of funds appropriated under
14 subsections 5(1) and 5(6) of this act shall be the
15 Governor of Chuuk State or his designee; the allottee
16 of funds appropriated under subsection 5(2) of section
17 5 of this act shall be the Mortlock Islands
18 Development Authority; the allottee of funds
19 appropriated under subsection 5(3) of this act shall
20 be the Mayor of Weno Municipal Government or his
21 designee; the allottee of funds appropriated under
22 subsection 5(4) of section 5 of this act shall be the
23 Executive Director of the Southern Namoneas
24 Development Authority; the allottee of funds
25 appropriate under subsection 5(5) of section 5 of this

1 act shall be the Faichuk Development Authority. The
2 authority of the allottee to obligate funds
3 appropriated by this act shall lapse on September 30,
4 2026.”

5 Section 2. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its
7 becoming law without such approval.
