#### PUBLIC LAW NO. 23-82

#### AN ACT

To further amend Public Law No. 18-70, as amended by Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-41, 19-52, 19-73, 19-82, 19-101, 19-114, 19-139, 20-07, 20-16, 20-36, 20-52, 20-81, 20-84 and 21-15, 21-113, 21-123, 21-175, 21-192, 21-208, 21-222, 22-75 and 22-130, by amending sections 3 and 6 thereof, to change the use and extend the lapse date of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

14	further amended to read as follows:
15	"Section 6. Allotment and management of funds and lapse
16	date. All funds appropriated by this act shall be
17	allotted, managed, administered and accounted for in
18	accordance with applicable laws, including, but not
19	limited to, the Financial Management Act of 1979. The
20	allottee shall be responsible for ensuring that these
21	funds, or so much thereof as may be necessary, are used
22	solely for the purpose specified in this act, and that
23	no obligations are incurred in excess of the sum
24	appropriated. The allottee of the funds appropriated
25	under section 2 of this act shall be the Governor of Yap

2	subsection 2(i) shall be the President of COM-FSM. The
3	allottee of funds appropriated under sections 3 and 4 of
4	this act shall be the President of the Federated States

6	appropriated under subsections a, b, c, d, e, f, g, h,
7	i, j, k, l, m, n, o, s, t, u, v, w, x, ag, ah, aj, ap
8	and aq of section 3 this act shall be the Mayor of Lelu

11	act shall be the Governor of Kosrae or his designee; the

19	Lapalap of Madolenihmw; the allottee of funds
20	appropriated under subsection 4(4)(f) shall be the Mayor
21	of Mwokilloa Municipal Government or his designee the
22	allottee of funds appropriated under subsection 4(4)(1)
23	shall be the Mayor of Pingelap Municipal Government or
24	his designee. The allottee of funds appropriated under
25	subsections $5(1)$ and $5(6)$ , of this act shall be the

1	Governor of Chuuk State or his designee. The allottee
2	of funds appropriated under subsection 5(2) of this act
3	shall be the Mortlock Islands Development Authority. The
4	allottee of funds appropriated under subsection 5(3) of
5	this act shall be the Mayor of Weno Municipal Government
6	or his designee. The allottee of funds appropriated
7	under subsection 5(4) of this act shall be the Southern
8	Namoneas Development Authority. The allottee of funds
9	appropriated under subsection 5(5) of this act shall be
10	the Faichuk Development Authority. The authority of the
11	allottee to obligate funds appropriated by this act
12	shall lapse on September 30, 2026."
13	Section 3. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its
15	becoming law without such approval.
