## AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127, 21-20, 21-117, 21-169, 21-174, 21-194, 21-205, 21-233, 22-15, 22-54, 22-85, 22-109 and 23-52, by amending sections 3 and 6 thereof, to change the use and change the lapse date of funds previously appropriated therein, to fund public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

"Section 6. Allotment and management of funds and lapse date. All fund appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws including, but not limited to, the applicable laws, including, but not limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State. The allottee of funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsections 3(a), (b), (c), (d), (e), (f), (g), (h), (t), (u), (v), (ag), (ar) and (as) of this act shall be the Mayor of Utwe Municipal Government or his designee; the allottee of funds appropriated under subsections 3(k), (w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae), (af), (ah), (ai), (aj), (ak), (al), (am), (an), (ao), (ap) and (aq) of this act shall be the Mayor of Tafunsak Municipal

1	Government or his designee; the allottee of funds
2	appropriate under subsections $4(1)(a)$ , $(b)$ , $(c)$ , $(e)$ , $(f)$ ,
3	and 4(2) shall be the Secretary of the Department of
4	Transportation, Communications and Infrastructure or his
5	designee; the allottee of funds appropriated under
6	subsections 4(1)(d), 4(3)(b), 4(3)(d), 4(3)(e), 4(3)(h),
7	4(3)(k) and 4(3)(1) shall be the Pohnpei Transportation
8	Authority (PTA). The allottee of funds appropriated under
9	subsections 5(1) and 5(6) of this act shall be the Governor
10	of Chuuk State or his designee. The allottee of funds
11	appropriated under subsection 5(2) of this act shall be the
12	Mortlock Islands Development Authority. The allottee of
13	funds appropriated under subsection 5(3) of this act shall
14	be the Mayor of Weno Municipal Government or his designee.
15	The allottee of funds appropriated under subsection 5(4) of
16	this act shall be the Southern Namoneas Development
17	Authority. The allottee of funds appropriated under
18	subsection 5(5) of this act shall be the Faichuk
19	Development Authority. The authority of the allottee to
20	obligate funds appropriated by this act shall lapse on
21	September 30, 2026."
