

AN ACT

To further amend Public Law No. 21-43, as amended by Public Laws Nos. 21-54, 21-71, 21-82, 21-103, 21-107, 21-158, 21-186, 21-235, 22-16, 22-50, 22-68, 22-123, 22-149 and 22-192 by amending section 6 thereof, to extend the lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-43, as amended
2 by Public Laws Nos. 21-54, 21-71, 21-107, 21-158, 21-235 and 22-
3 123, is hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that no
12 obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee; PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(f) of this act shall
17 be the President of the COM-FSM Institute. The allottee

1 of funds appropriated under sections 3 and 4 of this act
2 shall be the President of the Federated States of
3 Micronesia or his designee; PROVIDED THAT, the allottee of
4 funds appropriated under subsection 3(1) of this act shall
5 be the Governor of Kosrae State or his designee; the
6 allottee of funds appropriated under subsection 3(2) of
7 this act shall be the Mayor of Lelu Town Government or his
8 designee. The allottee of funds appropriated under
9 section 4(1) and 4(3)(1) of this act shall be the Vice
10 President; The allottee of funds appropriated under
11 subsection 4(1)(a) of this act shall be the Secretary of
12 the Department of Transportation, Communications and
13 Infrastructure or his designee, except that the allottee
14 of funds appropriated under subsections 4(2)(e), 4(4)(j),
15 4(4)(k), 4(4)(l) and 4(4)(m) of this act shall be the
16 Pohnpei Transportation Authority (PTA); the allottee of
17 funds appropriated under subsections 4(2)(l), 4(3)(d) and
18 4(3)(f) of this act shall be the Secretary of the
19 Department of Education or his designee; the allottee of
20 funds appropriated under subsection 4(2)(h) of this act
21 shall be the President of COM-FSM; the allottee of funds
22 appropriated under subsection 4(2)(m) of this act shall be
23 the Mayor of Nukuoro Municipal Government or his designee;
24 the allottee of funds appropriated under subsection
25 4(2)(j) of this act shall be the Secretary of the FSM

1 Department of Resources and Development; the allottee of
2 funds appropriated under subsections 4(3)(a), 4(3)(b),
3 4(3)(e), 4(3)(h), 4(3)(i) and 4(3)(k) of this act shall be
4 the Meninkeder of Madolenihmw; the allottee of funds
5 appropriated under subsection 4(3)(c) of this act shall be
6 the Chief Justice of Madolenihmw Municipal Government; the
7 allottee of funds appropriated under subsection 4(3)(g) of
8 this act shall be the Luhkenmoanlap of Kittu; the allottee
9 of funds appropriated under subsection 4(3)(j) of this act
10 shall be the Speaker of Isokonedu of Kittu; the allottee
11 of funds appropriated under subsection 4(3)(m) of this act
12 shall be the Director of Pohnpei Public Safety. The
13 allottee of the funds appropriated under sections 5(1) and
14 5(6) of this act shall be the Governor of Chuuk State or
15 his designee; the allottee of the funds appropriated under
16 subsection 5(2) of this act shall be the Mortlocks Island
17 Development Authority (MIDA); the allottee of the funds
18 appropriated under subsection 5(4) of this act shall be
19 the Southern Namoneas Development Authority; the allottee
20 of the funds appropriated under subsection 5(5) of this
21 act shall be the Faichuk Development Authority. The
22 allottee of funds appropriated under subsection 5(3) of
23 this act shall be the Mayor of Weno Municipal Government
24 or his designee. The authority of the allottee to

1 obligate funds appropriated by this act shall lapse on
2 September 30, 2026.”

3 Section 2. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.
