PUBLIC LAW NO. 23-89

AN ACT

To further amend Public Law No. 21-43, as amended by Public Laws Nos. 21-54, 21-71, 21-82, 21-103, 21-107, 21-158, 21-186, 21-235, 22-16, 22-50, 22-68, 22-123, 22-149 and 22-192 by amending section 6 thereof, to extend the lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-43, as amended

2 by Public Laws Nos. 21-54, 21-71, 21-107, 21-158, 21-235 and 22-

3 123, is hereby further amended to read as follows:

"Section 6. Allotment and management of funds and lapse date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State or his designee; PROVIDED THAT, the allottee of funds appropriated under subsection 2(f) of this act shall be the President of the COM-FSM Institute. The allottee

| Department of Education or his designee; the allottee of |
| funds appropriated under subsection 4(2)(h) of this act |
| shall be the President of COM-FSM; the allottee of funds |
| appropriated under subsection 4(2)(m) of this act shall be |
| the Mayor of Nukuoro Municipal Government or his designee; |
| the allottee of funds appropriated under subsection |
| 4(2)(j) of this act shall be the Secretary of the FSM |

| Department of Resources and Development; the allottee of |

| the Southern Namoneas Development Authority; the allottee |
| of the funds appropriated under subsection 5(5) of this |
| act shall be the Faichuk Development Authority. The |
| allottee of funds appropriated under subsection 5(3) of |
| this act shall be the Mayor of Weno Municipal Government |
| or his designee. The authority of the allottee to |
