

AN ACT

To further amend Public Law No. 21-201, as amended by Public Laws Nos. 21-219, 21-223, 21-229, 21-241, 22-28, 22-31, 22-51, 22-67, 22-97 and 22-104, by amending section 6 thereof, for the purpose of changing the lapse date of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-201, as amended
2 by Public Laws Nos. 21-219 and 22-51, is hereby further amended
3 to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee. The allottee of funds
16 appropriated under sections 3 and 4 of this act shall be
17 the President of the Federated States of Micronesia or

1 his designee; PROVIDED THAT the allottee of funds
2 appropriated under subsection 3(1) of this act shall be
3 the Governor of Kosrae State or his designee; the
4 allottee of funds appropriated under subsection 3(2) of
5 this act shall be the Mayor of Lelu Town Government or
6 his designee; the allottee of funds appropriated under
7 subsections 4(1) and 4(2) of this act shall be the
8 Secretary of the Department of Transportation,
9 Communications and Infrastructure or his designee;
10 EXCEPT THAT the allottee of funds appropriated under
11 subsections 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(e), 4(2)(h),
12 4(2)(i), 4(2)(j), and 4(2)(k) of this act shall be the
13 Pohnpei Transportation Authority; the allottee of funds
14 appropriated under subsection 4(2)(d) of this act shall
15 be the President of the COM-FSM, the allottee of funds
16 appropriated under subsection 4(2)(g) of this act shall
17 be the FSM Telecommunications Corporation. The allottee
18 of funds appropriated under subsections 4(3)(a),
19 4(3)(b), 4(3)(d), 4(3)(f), 4(3)(i), 4(3)(m) and 4(3)(t)
20 of this act shall be the Pohnpei Transportation
21 Authority; the allottee of funds appropriated under
22 subsections 4(3)(c), 4(3)(e), 4(3)(g), 4(3)(h), 4(3)(j),
23 4(3)(k), 4(3)(l), and 4(3)(o) of this act shall be the
24 Meninkeder of Madolenihmw; the allottee of funds
25 appropriated under subsections 4(3)(n) and 4(3)(q) of

1 this act shall be the Secretary of the Department of
2 Health and Social Affairs or his designee; the allottee
3 of funds appropriated under subsections 4(3)(p), 4(3)(r)
4 and 4(3)(s) of this act shall be the Vice President of
5 the Federated States of Micronesia; The allottee of the
6 funds appropriated under subsections 5(1), 5(2)(j) and
7 5(6) of this act shall be the Governor of Chuuk State or
8 his designee; the allottee of the funds appropriated
9 under subsection 5(2) of this act shall be the Mortlocks
10 Island Development Authority (MIDA); the allottee of
11 funds appropriated under subsection 5(3) of this act
12 shall be the Mayor of Weno Municipal Government or his
13 designee the allottee of the funds appropriated under
14 subsection 5(4) of this act shall be the Southern
15 Namoneas Development Authority; the allottee of the
16 funds appropriated under subsection 5(5) of this act
17 shall be the Faichuk Development Authority. The
18 authority of the allottee to obligate funds appropriated
19 by this act shall lapse on September 30, 2024.”
